Subject: GROWING INTERCEPTION OF WOOD PACKING MATERIAL CARRYING TEXTILE PRODUCTS IN EUROPEAN UNION ON VIOLATION OF INTERNATIONAL SANITARY PHYTOSANITARY MEASURES (ISPM-15)

It is informed for all concerned that pursuant of FBR directives vide letter C. No. 5(25)EP/08-Wood-69401-R dated 30.05.2018, all export of wooden pallets / wooden packaging material to any country specially member states of European Union shall not be allowed without Phytosanitary Certificate issued by the Department of Plant Protection (DPP).

2. All terminal operators are also directed to ensure submission of requisite Phytosanitary Certificate in respect of shipments cleared under Green Channel.
