SUBJECT:- SINDH BUDGET 2019-20 ----- INVITATION OF PROPOSALS IN RELATION TO THE SINDH SALES TAX ON SERVICES ACT, 2011 (SINDH ACT NO. XII OF 2011), AND THE RULES AND NOTIFICATIONS ISSUED THEREUNDER.
